



Volunteer Disclosure & Release Form

By signing the Volunteer Disclosure and Release form the Volunteer applicant agrees:

1. To complete the *Volunteer Information Form & Volunteer Background Check* form with factual information.
2. To disclose any criminal offenses and/or convictions relating or equivalent to:
 - Murder
 - Child Abuse
 - Rape
 - Any sexual offense, involving a minor, non-consenting adult, or person who is mentally disabled, incapacitated or physically helpless
 - Unlawful manufacture, distribution, or dispensing of drugs or any illegal substance
 - Child Pornography
 - Kid Napping of a Child
 - Child Neglect
3. To complete a successful background investigation.
4. To allow for the release of information to appropriate law enforcement agencies in order to conduct a background investigation.
5. To agree to disclose any future criminal convictions or violations.
6. To acknowledge the staff of the Boys & Girls Club of Massena will complete an inquiry regarding references and previous volunteer experiences.
7. To allow the Boys & Girls Club of Massena to perform at their discretion updated background checks.
8. To acknowledge that if any background and/or general information inquiry discloses any misrepresentation on the Volunteer Background Check form indicates an individual is not suited for voluntary service for the Boys & Girls Club of Massena, the applicant shall be denied the position, or, if already placed, will be immediately discharged.

Volunteer/Mentor Release Statement

I, the undersigned, hereby state that if accepted as a volunteer/mentor, I agree to abide by the rules and regulations of the Boys & Girls Club of Massena (hereafter known as the "Club

I have not been convicted of (a) any felony of any kind, or any misdemeanor involving (b) harm or threat of harm to another person, (c) controlled substances, (d) acts of a sexual nature, or (e) cruelty to animals. I am not under current indictment. Further, I hereby fully release, discharge and hold harmless the Club, participating organizations and all of their employees, officers, directors, and coordinators from any and all liability, claims, causes of action, costs and expenses which may be or may at any time hereafter become attributable to my participation with the Club.

I understand that the Board reserves the right to terminate me from the Club program without cause. I give permission for Club to conduct a criminal background check as part of the screening. This includes verification of personal and employment references as well as a criminal check with the authorities. The Club has final right of acceptance of the applicant and reserves the right to terminate anyone from the Club at any time. I have read this Release Statement and agree to the contents. I certify that all statements in this application are true and accurate.

I authorize investigation of all statements contained in this application. I understand that misrepresentation or omission of facts called for is cause for dismissal. If accepted as a volunteer, I agree to abide by the policies and standards of the Boys and Girls Clubs of Massena, fulfill training requirements and volunteer responsibilities to the best of my ability. If for any reason, I find that I am unable to carry out my volunteer responsibilities, I will notify the President.
